You are invited to attend the 2021 General Meeting (**GM**) of Cardno Limited (**Cardno**), which will take place on Friday, 3 December 2021 at 10:00am AEST (Brisbane time).

Having regard for the COVID-19 pandemic, social distancing requirements and the health and safety of all involved, the 2021 GM will be held as a virtual event. Shareholders and visitors will not be able to physically attend the GM.

In accordance with the Treasury Laws Amendment (2021 Measures No. 1) Act 2021, Cardno will not be dispatching physical copies of the Notice of Meeting (**Notice**). Instead, a copy of the Notice will be available under the "ASX Announcements" section of Cardno's website at https://www.cardno.com/investor-centre/.

As you have not elected to receive Notices by email, a copy of your personalised proxy form is enclosed for your convenience. Shareholders are encouraged to complete and lodge their proxies online or otherwise in accordance with the instructions set out in the proxy form and the Notice.

The Notice is important and should be read in its entirety. How you can participate in the GM online

Shareholders can participate in the meeting online entering the url "https://web.lumiagm.com/327063152" in the browser from a computer, smartphone, or tablet.

The Lumi online platform will allow shareholders to listen to the GM, vote and ask questions online in real time. Visitors to the GM will be able to listen to the GM via the Lumi online platform but will not have access to vote or ask questions.

If you are planning to attend the GM via one of the online platforms referred to above, we encourage you to submit a proxy and any questions ahead of the meeting.






Once logged in, you will see the home page, which displays the meeting title and name of the registered securityholder or nominated proxy.




To view the webcast you must tap the broadcast arrow on your screen and press the play button. Click the arrow to switch between screens.

To ask a question tap on the question icon , type your question in the chat box at the top of the screen and select the send icon. Confirmation that your message has been received will appear.


To ask a question verbally follow the instructions on the home page $\hat{\mathbf{n}}$ of the virtual meeting platform.
